OPPORTUNITY TO OBSERVE THE U.S. NUCLEAR REGULATORY COMMISSION PERIODIC ADVANCED REACTOR STAKEHOLDER MEETING (STC-21-044)

Purpose: To provide notice that the U.S. Nuclear Regulatory Commission (NRC) staff is conducting a public teleconference to discuss with the nuclear industry and other stakeholders the initiatives within the industry and NRC related to the development and licensing of non-light water reactors.

Background: The NRC staff is preparing an Advanced Nuclear Reactor (ANR) Generic Environmental Impact Statement (EIS) for small-scale advanced nuclear reactors for streamlining the environmental review process for future small-scale ANR applications. The purpose of an ANR Generic EIS is to determine (1) which environmental impacts could result in the same generic impact for different ANR designs that fit within the parameters set in the Generic EIS, and (2) which environmental impacts could result in different levels of impacts requiring a plant-specific analysis. Environmental reviews for small-scale ANR license applications could incorporate the ANR Generic EIS by reference and provide site-specific information and analyses in a Supplemental EIS.
